The source imagery was acquired from 20230512 - 20230531 with a Digital Sensor System (DSS) Version 6. The original images were acquired at a higher resolution to support the final ortho-rectified mosaic.

Process Steps:

- 2023-07-21 00:00:00 - Mosaic's were generated from 4-band (red, green, blue, near-infrared) ortho-rectified imagery. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit RGBI. The DEM source is 30 meter posting USGS NED. Cubic convolution resampling

method was used to create the final ortho-rectified mosaic. Original image tiles are 3.0 km by 3.0 km squares.
