4X topobathymetric lidar system. Data were processed to an initial LAS format using the Leica Lidar Survey Studio (LSS) software. The NovAtel Inertial Explorer software was utilized for GPS and inertial processing. Water refraction correction was applied to returns below the water surface within LSS. Data were then combined into 500m x 500m tiles. GeoCue, Terrasolid, and LP360 software was used for data visualization, 3D editing, and export to final LAS file. Final data were exported in LAS 1.4 format in NAD83 (2011) horizontal and vertical datum.

- 2023-10-16 00:00:00 - The NOAA Office for Coastal Management (OCM) received files in laz format.
