This data set contains 4-band ortho-rectified mosaic tiles, created as a product from the NOAA Integrated Ocean and Coastal Mapping (IOCM) initiative. They are 8 bit RGB and NIR band stacked mosaics with an alpha channel. The source imagery was acquired on 20231115 with an Applanix Digital Sensor System (DSS). The original images were acquired at a higher resolution to support the final ortho-rectified mosaic.

Process Steps:

- 2023-12-05 00:00:00 - Mosaic's were generated from 4-band (red, green, blue, near-infrared) ortho-rectified imagery. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit RGBI. The DEM source is 30 meter posting USGS NED. Cubic convolution resampling

method was used to create the final ortho-rectified mosaic. Original image tiles are 3.0 km by 3.0 km squares.
