A triangulated irregular network (TIN) was generated from these data and rasterized at a 1 m spatial resolution using the LAStools 'blast2dem' utility. Void polygons delineating areas of extremely sparse or non-existent bathymetric coverage were used in ArcGIS to clip large areas of interpolation in the DEM. DEMs were reviewed using Global Mapper and ArcGIS to check for surface anomalies, incorrect elevations, and unacceptable voids in the data.
