This data set contains 4-band ortho-rectified mosaic tiles, created as a product from the NOAA Integrated Ocean and Coastal Mapping (IOCM) initiative. They are 8 bit RGB and NIR band stacked mosaics with an alpha channel. The source imagery was acquired on 20230911 with a Digital Sensor System (DSS). The original images were acquired at a higher resolution to support the final ortho-rectified mosaic.

Process Steps:

- 2023-12-05 00:00:00 - Mosaic's were generated from 4-band (red, green, blue, near-infrared) ortho-rectified imagery. Mosaic data have not been histogram stretched and only minimal color balancing has been performed. The images are in 8 bit RGBI.

The DEM source is 30 meter posting USGS NED. Cubic convolution resampling method was used to create the final ortho-rectified mosaic. Original image tiles are 3.0 km by 3.0 km squares.
