Through an integrative assessment, the project team leveraged knowledge from community members, synthesized and compiled existing information, and applied a triple bottom line lens ( economic, social, and environmental) to portray current conditions and uses in the estuary, and generate options and recommendations for local governments to improve their estuarine and shoreland management.

This integrated assessment project was funded by NOAA through the National Estuarine Research Reserve System Science Collaborative to evaluate options for action. It did not produce any new data.
