Process Steps:

- 2015-01-01 00:00:00 - The Biotic feature layer was converted to Coastal and Marine Ecological Classification Standard (CMECS) 2012 format (<https://iocm.noaa.gov/cmecs>). This was accomplished by extracting the biotic attributes in the original single benthic habitat dataset(shapefile) and exporting them as a feature layer into the larger sfb_ca11.gdb geodatabase. No new delineations were made as part of this process. Polygons in the original shapefile for which no biotic attribute could be assigned were deleted from this feature layer. The full CMECS biotic hierarchy and codes are expressed as attributes for this final product.
