Process Steps:

- 2015-01-01 00:00:00 - The data was converted to Coastal and Marine Ecological Classification Standard (CMECS) 2012 format (<https://iocm.noaa.gov/cmecs>). This was accomplished by reviewing the substrate and biotic attributes in the original single benthic habitat dataset(shapefile) and assigning a CMECS Geoform attribute to those polygons. The original source imagery was visually interpreted to determine a geoform attribute where possible. No new delineations were made as part of this process. The original polygon boundaries were delineated based on visible biota and surface sediment signatures and not on geomorphological features, therefore these boundaries may not directly correspond to the extent of geoform features in this layer. Polygons in the original shapefile for which no geoform attribute could be assigned were deleted from this feature layer. The full CMECS Geoform hierarchy and codes were expressed as attributes for the final product. layers.
