1.2. Summary description of the data:

The Apalachicola Bay National Estuarine Research Reserve and the NOAA Office for Coastal Management worked together to map benthic habitats within Apalachicola Bay, Florida. The bay and the lower portions of four distributaries were surveyed on 11-22 October 1999 using three benthic sampling techniques. This data set represents the benthic community information gathered from grab sampling. Grabs were collected at 136 stations throughout the bay.

Process Steps:

- Grab samples were collected using a 0.04 square meter Shipek grab. Grabs were washed on the boat and sieved through a 0.5-mm mesh. The sieve contents were then stored in a 10% buffered formalin solution and processed by Barry Vittor and Associates, Inc., Mobile, Alabama. In the laboratory, organisms were separated from the remaining debris by flotation and handpicking, identified by experienced taxonomists, and enumerated. Identifications were to the lowest practical identification level (LPIL) when not to the species level.
