Process Steps:

- 2009-01-01 00:00:00 - Using Caris 7.0, the side scan sonar (SSS) trackplot was created from the GPS positions recorded in the XTF file header. Real-time navigation was processed with POSpac 5.2 utilizing the logged POS MV data and base station data.
- 2009-01-01 00:00:00 - The trackplot was imported into ArcGIS, where it was qc'd for accuracy. A list of the SSS_lines were compared against a list of delivered xtf files and any discrepancies were investigated.
- 2010-01-01 00:00:00 - The NOAA Office for Coastal Management and the New York Dept. of Environmental Conservation performed quality assurance reviews of the data to ensure that it met the contract specifications.
