- 2014-11-15 00:00:00 - This dataset is comprised of 3-band 24-bit (red, green, and blue bands) DOI cells in a Geotiff format, at a 15cm pixel resolution, based on DEM surface created for the project area. This dataset was created from source imagery acquired from the MIST high resolution wide angle camera system or A3 edge large-format mapping and oblique camera system.
