The coordinate locations are from NMFS' Final Rule to implement Amendment 19 to the Pacific Coast Groundfish Fishery Management Plan (71 FR 27408; May 11, 2006). In order to minimize to the extent practicable adverse effects from fishing, the final rule prohibits fishing with various gear types within these areas. The prohibitions are listed in Section 660.306 and the official coordinates are listed in Sections 660.397, 660.398, and 660.399 of the final rule.
