Unexploded ordnances are explosive weapons (bombs, bullets, shells, grenades, mines, etc.) that did not explode when they were employed and still pose a risk of detonation.

Dissolve based on Name, Phase, Site ID, District, MRA number, MRS number, State,

Program, Category and Division Field calculate the Category field in the FUDS layer from the appropriate attributes in the joined table. Merge source layers together and remove extraneous attributes from resulting attribute table. Add "Program" attribute and populate with name of program for each layer (FUDS, MRA, MRS). Eliminate features occurring on land by clipping (preserve intersecting area) to FederalAndStateWaters. Convert Inventories into excel format and combine into single file.
