Process Steps:

- 2018-03-14 00:00:00 - Aerial Photography Acquisition: Aerial photography was acquired, in eight (8) mission, using an UltraCam Eagle at an altitude of 6,829' AGL to support 0.5-foot pixel resolution color digital orthophotography. Airborne GPS and IMU data was collected during the photography acquisition and supported by CORS GPS- stations. Data acquisition was completed on 13th of March 2018.
- 2018-09-26 00:00:00 - Orthorectification: SimActive's Correlator3D software was used to rectify and mosaic the data. Following the initial generation of the orthophoto tiles, they were visually inspected and corrected where necessary before being saved out as the final orthophoto deliverable tiles.
