Seven turbines are operational, five at the Block Island Wind site and two at the Coastal Virginia Offshore Wind site. The seven turbines are responsible for 42 megawatts of power generation capacity. Additional turbines are actively under construction at the Vineyard Wind 1 site, South Fork Wind site, Revolution Wind site, and the Coastal Virginia Offshore Wind site.
