into the associated attributes in the Coastal Counties layer. Download Census and ACS data from American Factfinder as comma-delimited (*.csv) documents. Delete extraneous attributes. Merge select omitted independent cities from TIGER/Line Shape with Coastal Counties (Washington DC, Fairfax city, Falls Church city, Fredricksburg city, Manassas city, Manassas Park city, Richmond city, and Colonial Heights city). Utilize topology to align polygon edges.
