Necessary means the habitat required to support a sustainable fishery and the managed species' contribution to a healthy ecosystem. Highly migratory species managed by NOAA Fisheries include tunas, some sharks, swordfish, billfish, and other highly sought-after fish such as Pacific mahi mahi.
