Source data includes values from January 1, 1979, to December 31, 2010, at hourly temporal resolution, with a spatial resolution of 0.313 degrees latitude x 0.312 degrees longitude. Values for wind speed are in meters per second and wind direction in degrees from True North.

- 4) The monthly means were averaged together for all years (1979-2010)
