1.1. Name of the Data, data collection Project, or data-producing Program:

2013 Oregon Department of Geology and Mineral Industries (DOGAMI) Oregon Lidar DEM: Scappoose

1.2. Summary description of the data:

WSI collected Light Detection and Ranging (LiDAR) data for the Oregon LiDAR Consortium (OLC) Scappoose study area. The Scappoose project area encompasses approximately 36,600 acres in Columbia and Washington County, Oregon. The study area is predominantly comprised of rural and forested lands. The collection of high resolution geographic data is part of an ongoing pursuit to amass a library of information accessible to government agencies as well as the general public.

Between July 1 and July 2, 2013, WSI employed remote-sensing lasers in order to obtain a total area flown of 37,223 acres. Settings for LiDAR data capture produced an average resolution of at least eight pulses per square meter. The LiDAR survey utilized a Leica ALS60 mounted in a Partenavia P.68. The system was programmed to emit single pulses between 96 and 106 kHz and flown at 900 meters AGL, capturing a scan angle of +/-15 degrees from nadir. These settings were developed to yield points with an average native density of greater than eight pulses per square meter over terrestrial surfaces.

Final products included lidar point cloud data, one-meter digital elevation models of bare earth ground model and highest-hit returns, intensity rasters, study area vector shapes, and corresponding statistical data. Final deliverables were projected in Oregon Statewide Lambert Conformal Conic. This metadata was created for the bare earth digital elevation models.

Process Steps:

- 2013-01-01 00:00:00 - The LiDAR survey occurred between July 1 and July 2, 2013 utilizing a Leica ALS60 mounted in a Partenavia P.68. The system was programmed to emit single pulses between 96 and 106 kHz and flown at 900 meters AGL, capturing a scan angle of +/-15 degrees from nadir. These settings were developed to yield points with an average native density of greater than eight pulses per square meter over terrestrial surfaces.
- 2017-05-01 00:00:00 - The NOAA Office for Coastal Management (OCM) received the files in the proprietary ESRI grid format. The files were converted to floating point GeoTIFF format in vertical meters using gdal_translate from GDAL version 2.1.1.
- 2023-08-15 00:00:00 - Files were converted to cloud optimized geotiff format to support streaming and the vertical units were reverted to feet to match the horizontal units.
