The Nominal Point Density of this dataset is approximately 1.66 meters for unobscured areas. The LiDAR discrete-return point cloud data were originally available in the

American Society for Photogrammetry and Remote Sensing (ASPRS) LAS V1.2 format.

Process Steps:

- 2013-03-01 00:00:00 - The NOAA Office for Coastal Management (OCM) received topographic files in LAS format. The files contained lidar elevation and intensity measurements. The data were received in projected California State Plane Zone 0403 coordinates and were vertically referenced to NAVD88. The vertical units of the data were feet. OCM performed the following processing for data storage and Digital Coast provisioning purposes: 1. High Noise (bad elevations) were removed from tiles 29J and 30J. All elevations greater than 1000 feet were removed. 2. Horizontally the data was converted from projected California State Place Zone 0403 coordinates (feet) to geographic NAD83 coordinates (decimal degrees) 3. Vertically the data was converted from orthometric NAVD88 heights (feet) to ellipsoidal NAD83 (meters) using GEOID03 (assumed)
