Process Steps:

- LiDAR was collected within Duval County. The LiDAR system acquisition parameters were developed based on a maximum average ground sample distance of 4 feet. One Optec ALTM 3100C-EA 100 kHz lidar system was used for acquisition.
- 2009-01-01 00:00:00 - The NOAA Office for Coastal Management (OCM) received files in LAS format. The files contained LiDAR intensity and elevation measurements. OCM performed the following processing on the data to make it available within Digital Coast: 1. The data were converted from State Plane Florida East coordinates to geographic coordinates. 2. The data were converted from NAVD88 heights to ellipsoid heights using Geoid03. 3. The LAS header fields were sorted by latitude and updated.
