The data arrived with separate files for each pulse return, therefore OCM combined like areas then retilled for smaller tile areas. 2. The data were converted from projected orthometric coordinates to geographic coordinates. 3. The LAS data were sorted by latitude and the headers were updated then stored as LAZ data.
