Process Steps:

- 2007-06-11 00:00:00 - LIDAR data was collected using Merrick's ALS60 sensor. The raw data was verified in MARS software for complete coverage of the project area, and boresighted to align the flightlines. Raw data files were parsed into manageable client-specific tiles. These tiles were then processed through automated filtering that separates the data into different classification groups: error points, ground points, and canopy/building points. The data was next taken into a graphic environment to reclassify the erroneous points that may remain in the LIDAR point cloud after auto filter.
- 2011-05-10 00:00:00 - The NOAA Office for Coastal Management (OCM) received files in LAS format. The files contained LiDAR intensity and elevation measurements. OCM performed the following processing on the data for data storage purposes and Digital Coast provisioning: 1. The data were converted from UTM, Zone 16 coordinates to geographic (NAD83) coordinates; 2. The data were filtered to remove elevation outliers; 3. The data were converted from NAVD88 heights to ellipsoid heights using Geoid03; 4. The LAS header fields were sorted by latitude and updated;
