## **1. General Description of Data to be Managed**

### **1.1. Name of the Data, data collection Project, or data-producing Program:**

### **1.2. Summary description of the data:**

WSI, a Quantum Spatial company, has collected lidar data for the Oregon LiDAR Consortium (OLC) Crooked Ochoco study area. This study area is adjacent to the Ochoco study area delivered July 31, 2013. The northwestern section of Crooked Ochoco was acquired before snow fell in the study area at the end of 2013. Acquisition of the remaining areas was completed in summer 2014. The collection of high resolution geographic data is part of an ongoing pursuit to amass a library of information accessible to government agencies as well as the general public.

In September and December 2013, and May and June 2014, WSI employed lidar in order to obtain a total area flown of 159,270 acres. Settings for LiDAR data capture produced an average resolution of at least eight pulses per square meter.

September flights utilized a Leica ALS 50 sensor mounted in a Piper Navajo. December flights utilized a Leica ALS 70 sensor mounted in a Cessna Caravan. May 2014 flights used a Leica ALS 60 sensor mounted in a Cessna Caravan and the June 2014 flights used Leica ALS 70 sensor in a Partenavia P68.

Final products included lidar point cloud data, one-meter digital elevation models of bare earth ground model and highest-hit returns, intensity rasters, study area vector shapes, and corresponding statistical data. Final deliverables were projected in Oregon Statewide Lambert Conformal Conic. Lidar point clouds were projected back to geographic coordinates for storage in the Digital Coast Data Access Viewer.

Process Steps:

- 2014-01-01 00:00:00 - September flights utilized a Leica ALS 50 sensor mounted in a Piper Navajo. December flights utilized a Leica ALS 70 sensor mounted in a Cessna Caravan. May 2014 flights used a Leica ALS 60 sensor mounted in a Cessna Caravan and the June 2014 flights used Leica ALS 70 sensor in a Partenavia P68. The system was flown at a variable height above ground level, capturing a scan angle of +/-15 degrees from nadir. These settings were developed to yield points with an average native density of greater than eight pulses per square meter over terrestrial surfaces.
- 2017-07-01 00:00:00 - The NOAA Office for Coastal Management (OCM) received the files in laz format from the Oregon Lidar Consortium. The files contained Lidar elevation and intensity measurements. The data were in Oregon Lambert (NAD83 2011 Epoch 2010.0), International Feet coordinates and NAVD88 (Geoid12a) vertical feet. OCM performed the following processing to the data to make it available within the Digital Coast: 1. The data were converted from Oregon Lambert (NAD83), International Feet coordinates to geographic coordinates. 2. The vertical units of the data were converted from International feet to meters. 3. The data were converted from NAVD88 (orthometric) heights to NAD83(2011) ellipsoid heights using Geoid12a grids. The data was received without a metadata record. This record was produced based on the data quality report.
