2006 Puget Sound LiDAR Consortium (PSLC) Topographic LiDAR: Lewis County, WA

1.2. Summary description of the data:

Watershed Sciences, Inc. collected Light Detection and Ranging (LiDAR) data of Western Lewis County for the Puget Sound LiDAR Consortium. This data set covers approximately 400 square miles.

Data was collected in leaf-off conditions.

An Optech 3100 LiDAR system was mounted in a fixed-wing aircraft and flown 1,200 meters above ground level (AGL). A pulse repetition frequency (PRF) of 71 kHz with at least 100% overlap (minimum 50% side-lap) was used.

This data set achieved greater than 8 points per square meter.

5.1. Processing workflow of the data from collection or acquisition to making it publicly accessible

Process Steps:

- Acquisition. The LiDAR data was collected during March 2006. This was a leaf-off condition. An Optech 3100 LiDAR system was mounted in a fixed-wing aircraft and flown 1,200 meters above ground level (AGL). A pulse repetition frequency (PRF) of 71 kHz with at least 100% overlap (minimum 50% side-lap) was used. Greater than 8 points per square meter and near nadir scan angles were used to increase penetration of vegetation to ground surfaces. Spot spacing was less than or equal to 34 centimeters. Ground level GPS and aircraft IMU were collected during the flight.

- Processing. 1. Flight lines and data were reviewed to ensure complete coverage of the study area and positional accuracy of the laser points. 2. Laser point return coordinates were computed using the REALM survey suite and PosPac based on independent data from the LiDAR system, IMU, and aircraft. 3. The raw LiDAR file was assembled into flight lines per return with each point having an associated x, y, and z coordinate. 4. Visual inspection of swath to swath laser point consistencies within the study area were used to perform manual refinements of system alignment. 5. Custom algorithms were designed to evaluate points between adjacent flight lines. Automated system alignment was computed based upon randomly selected swath to swath accuracy measurements that consider elevation, slope, and intensities. Specifically, refinement in the combination of system pitch, roll and yaw offset parameters optimize internal consistency. 6. Noise (e.g., pits and birds) was filtered using REALM software tools based on known elevation ranges and included the removal of any cycle slips. 7. Using TerraScan and Microstation, ground classifications utilized custom settings appropriate to the study area. 8. The corrected and filtered return points were compared to the RTK ground survey points collected to verify the vertical and horizontal accuracies. 9. Points were broken into processing bins and output areas and output as laser points, TINed and GRIDed surfaces. Bare earth DEMs meet PSLC specifications.

- 2013-08-01 00:00:00 - The NOAA Office for Coastal Management (OCM) downloaded topographic files in .txt format from PSLC's website. The files contained lidar elevation, intensity, return number, class, scan angle and GPS time measurements. The data were received in Washington State Plane South Zone 4602, NAD83 coordinates and were vertically referenced to NAVD88 using the Geoid03 model. The vertical units of the data were feet. OCM performed the following processing for data storage and Digital Coast provisioning purposes: 1. The All-Return ASCII txt files were parsed to convert GPS Week Time to Adjusted Standard GPS Time. 2. The All-Return ASCII files were converted from txt format to las format using LASTools' txt2las tool. 3. The las tile 46123_g2_se_cc was found to have a corrupt bounding box. The bounding box was fixed (1500x1500m) using LASTools' lastile tool in conjunction with lasmerge. 4. The las files were converted from orthometric (NAVD88) heights to ellipsoidal heights using Geoid03. 5. The las files' vertical units were converted from feet to meters. 6. The las files were converted from a Projected Coordinate System (WA SP South) to a Geographic Coordinate system (NAD83). 7. The las files' horizontal units were converted from feet to decimal degrees.
