Process Steps:

- 2019-03-01 00:00:00 - Bare-Earth DEM Creation: Bare-Earth Digital Elevation Models (DEMs) were derived using the hydro break line and bare-earth (ground) lidar points, all DEMs were created with a grid spacing of 0.5 Meters. The DEMs were cut to tiles of 1,000 Meters X 1,000 Meters index, provided by the US Geological Survey.
- 2020-03-10 00:00:00 - Data were downloaded from the USGS in Imagine format and

Albers projection. GDAL was used to convert the DEM tiles into cloud optimized geotiff format for ingest into the Digital Coast Data Access System. (Citation: DEM files from USGS in Imagine format)
