Products: This VA_UpperMiddleNeck_2018_D18 project called for the planning, acquisition, processing, and derivative products of lidar data to be collected at an aggregate nominal pulse spacing (ANPS) of 0.71 meters (2ppsm). Project specifications are based on the U.S. Geological Survey National Geospatial Program Base Lidar Specification, Version 1.3. The original data was developed based on a horizontal projection/datum of NAD83 (2011), Albers Equal Area, meters and vertical datum of NAVD88 (GEOID12B), meters. Lidar data was delivered as processed Classified LAS 1.4 files, formatted to individual 1000 m x 1000 m tiles.

- 2023-11-28 00:00:00 - The NOAA Office for Coastal Management (OCM) downloaded

this data set from the USGS RockyWeb portal. The total number of files downloaded and processed was 11,503. The data were in Albers and UTM18 (NAD83 2011), meters, and NAVD88 (Geoid12B) elevations in meters. The data were classified as: 1 - Unclassified, 2 - Ground,, 7 - Noise, 9 - Water, 17 - Bridge Decks, and 20 - Ignored Ground. OCM processed all classifications of points to the Digital Coast Data Access Viewer (DAV). OCM performed the following processing on the data for Digital Coast storage and provisioning purposes: 1. An internal OCM script was run to check the number of points by classification and by flight ID and the gps and intensity ranges. 2. Internal OCM scripts were run on the laz files to convert from orthometric (NAVD88) elevations to ellipsoid elevations using the Geoid12B model, to convert to geographic coordinates, to assign the geokeys, to sort the data by gps time and zip the data to database and to http.
