- 2006-04-01 00:00:00 - Data from the 1 khz and 10khz lasers were combined and gridded at 4m resolution. The data were reclassified into a categorical grid theme and then converted to a feature format. Grid values were all assigned the same numerical value and dissolved on that attribute.
