Process Steps:

- 2005-01-01 00:00:00 - Depth soundings (in meters) were extracted from the NOAA NGCD GEODAS software by querying the latitude and longitudinal area encompassing the Olympic Coast national marine sanctuary, resulting in a point coverage with a depth attribute. A surface was then created with a kriging model in ArcInfo, then contoured at 10m. Contours were clipped to the bounds of the HMPR-108-2002-01 sonar survey effort. (Citation: GEODAS - GEOPhysical Data Systems for Hydrographic Survey Data)
