### 1.1. Name of the Data, data collection Project, or data-producing Program:

hab108\_0201\_west.TIF -- Side scan sonar image (West mosaic) from survey effort HMPR-108-2002-01 in the Olympic Coast National marine sanctuary.

### 1.2. Summary description of the data:

The side scan sonar image of the sea floor (120-350 m water depths) was mosaiced from data collected in 2002. An Edgetech DF1000 side scan system was used for geophysical surveying using only the 100Khz data. A Trimble DSM212H differential GPS was used for positioning. Navigation from the GPS and Gyro were logged in Hypack version 005B (CoastalOceanographics). Isis Sonar (Triton Imaging) was used to log the digital sonar packets and cable counter data. Data were captured at an 300 m range scale setting.

Process Steps:

- 2002-01-01 00:00:00 - Isis Sonar. Data logged as XTF format. Horizontal layback was calculated from logged cable out and depth sensor data.

- 2003-01-01 00:00:00 - Isis Sonar. Bottom track.
- 2003-01-01 00:00:00 - Isis Sonar. Apply custom TVG curve using  $-6 + 0.109 + (-13)$ , starting at first return.
- 2003-01-01 00:00:00 - Isis Sonar. Apply duration of 282m
- 2003-01-01 00:00:00 - Isis Sonar. Calculate and apply beam angle compensation.
- 2003-01-01 00:00:00 - Isis Sonar. Smooth navigation data using moving window filter. Mosaic individual lines at 1m pixelresolution and apply lackback calculation from cable out and depth sensor data.
- 2003-01-01 00:00:00 - Delph Map. Merge individual lines with overlay.
- 2003-01-01 00:00:00 - Delph Map. Export merged mosaic as Geotiff.
