1.2. Summary description of the data:

The Canadian ROPOS remotely operated vehicle (ROV) outfitted with video equipment (and other devices) was deployed from the NOAA Ship McAurthurII during May-June 2006 in an attempt to document the presence of critical hard bottom benthic habitats believed to exist in the waters of the Olympic Coast national marine sanctuary (OCNMS). Video data from specific dives falling within the bounds of the HMPR-118-2005-03c survey area were reviewed to describe various benthic characteristics as a tool for validating sonar imagery. Video mosaics were created from selected sections of video to assist with sonar image groundtruthing.

Process Steps:

- Using FinalCut Pro, clips of video were extracted from DVCAM into AVI containers

using the DVPRO compression setting.

- Virtual Dub was used to apply various color correcting filters, reduce the frame rate, and crop the video clips.
- Using YRSoft CFRM-Movie (developed at the CCOM at the University of New Hampshire), sequential movie frames were re-registered to produce a log file for use in subsequently building the mosaic. Default parameters were used.
- Using the rigid affine record (RRA) file produced from the previous step, Build-Mosaic was used to combine images stored as movie frames in a single mosaic on a basis of pair-wise transformations. This process produces a bitmap image.
- Center points of the beginning and ending video frames were used to georegister the video mosaic by corresponding with navigation fixes using the time stamps imprinted on the video.
- The bitmap mosaic was georeferenced using the Linear Referencing tool in ArcInfo 9.2 by loading a text file with corresponding rectification parameters calculated during the center file creation of Build Mosaic.
- Routes were created of each video segment using the navigation data associated with each video clip.
