### 1.2. Summary description of the data:

This data set contains sensitive biological resource data for seals, whales, porpoises, walruses, sea otters, and Steller sea lions in the Bristol Bay Subarea. The Subarea includes marine and coastal areas of Bristol Bay and part of the southern Alaska Peninsula. (This area extends from directly south of Goodnews Bay to slightly north of Port Seniavan along the Bristol Bay side of the Alaska Peninsula, as well as the Pacific Ocean side of the Alaska Peninsula from Cape Providence to Kupreanof Peninsula.) Vector polygons in this data set represent marine mammal distribution, haul-out sites, and rookeries. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for the Bristol Bay Subarea. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the M\_MAMPT (Marine Mammal Points) data layer, part of the larger Bristol Bay Subarea ESI database, for additional marine mammal information.

Process Steps:

- 2004-03-01 00:00:00 - Four main sources of data were used to depict distributions of marine mammals for this data layer: (1) personal interviews with resource experts from U.S. Fish and Wildlife Service (USFWS), Alaska Department of Fish and Game (ADF&G), and NOAA National Marine Fisheries Service (NMFS) and National Marine Mammal Laboratory (NMML); (2) hardcopy maps, including the 1986 ADF&G Alaska Habitat Management Guide, Western Alaska and Interior Region; (3) numerous published reports and books; and (4) digital data, including a 2001 USFWS sea otter aerial survey vector point coverage and a 2002 ADF&G Most Environmentally Sensitive Areas (MESA) vector polygon and point coverage. Concentration and seasonality information was provided by resource experts or was extracted from published sources or survey data.
