This data set comprises a portion of the ESI data for Columbia River. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

- 2004-08-01 00:00:00 - The main source of data used to depict the wetlands for this data layer was the Habitat Types of the Lower Columbia River provided by the Lower Columbia River Estuary Partnership. Adjustments to the polygons were made in cases where a wetland polygon was located partially or completely within

a water polygon from the HYDRO coverage. The polygons were also classified with the NOAA's ESI classification. No other adjustments were made to the original data.
