Guam and the Northern Mariana Islands ESI: FISH (Fish Polygons)

### 1.2. Summary description of the data:

This data set contains sensitive biological resource data for reef, pelagic, benthic, and estuarine fish species in Guam and the Northern Mariana Islands. Vector polygons in this data set represent fish concentration areas. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for Guam and the Northern Mariana Islands. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2005-08-01 00:00:00 - Two main sources of data were used to depict fish distribution and seasonality for this data layer: (1) personal interviews with resource experts from the National Oceanic and Atmospheric Administration (NOAA), Guam Department of Agriculture's Division of Aquatic and Wildlife Resources (DAWR), Guam Environmental Protection Agency (GEPA), The Nature Conservancy (TNC), Western Pacific Fishery Management Council (WPFMC), the Commonwealth of the Northern Mariana Islands (CNMI) Division of Environmental Quality (DEQ), CNMI Coastal Resources Management (CRM), and CNMI Division of Fish and Wildlife (DFW); and (2) survey data provided by Guam DAWR and CNMI DFW. The above digital and/or hardcopy sources were compiled by the project biologist to create the FISH data layer. Depending on the type of source data, three general approaches are used for compiling a biology data layer: (1) information gathered during initial interviews and from hardcopy sources are compiled onto U. S. Geological Survey 1:24,000 and 1:25,000 topographic quadrangles and digitized; (2) hardcopy maps are digitized at their source scale; (3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The compiled ESI, biology, and human-use data are plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews is conducted to review the maps. If necessary, edits to the FISH data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.

The database files are distributed both in the NOAA standard relational database format (see NOAA Technical Memorandum NOS ORCA 115) and in a simplified desktop flat file format. This metadata document includes information on both of these database formats.;
