Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. - 2005-08-01 00:00:00 - Two main sources of data were used to depict habitat distribution for this data layer: (1) personal interviews with resource experts from the National Oceanic and Atmospheric Administration (NOAA), the Commonwealth of the Northern Mariana Islands (CNMI) Divison of Environmental Quality (DEQ), Guam Division of Aquatic and Wildlife Resources (DAWR), Guam Environmental Protection Agency (GEPA), The Nature Conservancy (TNC), and the National Park Service (NPS); and (2) digital coverages including: a 2004 Guam/CNMI vector polygon benthic habitat data set provided by the NOAA National Ocean Service ( NOS) Biogeography Program; a draft 2005 Guam vector polygon benthic habitat data set provided by the NOAA Pacific Island Technical Assistant - Guam; and a 2005 Saipan Lagoon benthic habitat data set provided by CNMI DEO. The above digital and/or hardcopy sources were compiled by the project biologist to create the HABITATS data layer.
