This data set contains human-use resource data for grounded, abandoned, and derelict vessels in Guam and the Northern Mariana Islands. Vector points in this data set represent the vessel locations. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for Guam and the Northern Mariana Islands. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

- 2005-08-01 00:00:00 - The data source used to depict the vessels locations in this

data layer was the National Oceanic and Atmospheric Administration (NOAA) Abandoned Vessel Inventory (AVI) database. This database is a compilation of existing data from sources such as NOAA, U.S. Coast Guard, U.S. Navy, States, Territories, and the maritime industry, as well as original data from charts and interviews with local sources. In some cases, the position information in the database and on the ESI maps may be approximate or inaccurate. Furthermore, new vessels continue to become abandoned while older vessels degrade, shift in position, or are occasionally removed. Only a subset of vessels depicted on the maps were surveyed and verified in 2003, and changes in their status may have occurred since that time.
