### 1.2. Summary description of the data:

This data set contains vector polygons representing the coastal wetland habitats for Guam and the Northern Mariana Islands classified according to the Environmental Sensitivity Index (ESI) classification system. This data set comprises a portion of the ESI data for Guam and the Northern Mariana Islands. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the ESI (ESI Shoreline Types \x96 Lines) data layer, part of the larger Guam and Northern Mariana Islands ESI database, for additional coastal habitat information.

Process Steps:

- 2005-08-01 00:00:00 - The WETLANDS data layer was compiled from pre-existing

digital wetlands inventory data sets and expert review. These polygonal wetland types were not validated as part of the ESI shoreline classification. The wetlands classification schemes were converted to the ESI scale following NOAA Technical Memorandum NOS OR&R 11: Environmental Sensitivity Index Guidelines: Version 3.0: March 2002. In some cases, the digital wetlands polygons were clipped with the atlas shoreline. To create the WETLANDS data layer, review maps were plotted at a 1:24,000 scale for verification of polygonal attributes. See the Lineage section for additional information on the type of source data for this data layer. The compiled ESI, biology, and human-use data were plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews was conducted to review the maps. If necessary, edits to the WETLANDS data layer were made based on the recommendations of the resource experts, and final hardcopy maps and digital data were created.

The database files are distributed both in the NOAA standard relational database format (see NOAA Technical Memorandum NOS ORCA 115) and in a simplified desktop flat file format. This metadata document includes information on both of these database formats.;
