Hawaii ESI: M_MAMMAL (Marine Mammal Polygons)

1.2. Summary description of the data:

This data set contains sensitive biological resource data for endangered Hawaiian monk seals, endangered humpback whales, and other whales and dolphins in coastal Hawaii. Vector polygons in this data set represent marine mammal distribution and Hawaiian monk seal pupping and haul-out sites. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for Hawaii. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the M_MAMPT (Marine Mammal Points) data layer, part of the larger Hawaii ESI database, for additional marine mammal information.

Process Steps:

- 2001-11-01 00:00:00 - Two main sources of data were used to depict marine mammal distribution for this data layer: 1) Personal interviews with resource experts from National Marine Fisheries Service (NMFS), University of Hawaii (UH), Division of Land and Natural Resources (DLNR), and other agencies; and 2) the 1999 Mobley et al. "Results of Aerial Surveys of Marine Mammals in the Major Hawaiian Islands (1993-1998)" hardcopy report. Information gathered during a set of interviews was compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles. A second set of interviews was conducted following the data compilation phase, and edits were made based on recommendations by the resource experts. Maps and figures from the 1999 Mobley et al. report, which depicted concentration areas for cetacean species based on survey data collected between 1993-1998, were used in addition to expert knowledge.
