This data set contains sensitive biological resource data for raptors (bald eagle and osprey) in Maine and New Hampshire. Vector points in this data set represent bird nesting sites. Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for Maine and New Hampshire. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the BIRDS (Bird Polygons) data layer for additional bird information.

Process Steps:

- 2016-01-01 00:00:00 - The Birds points data layer was developed from direct consultation with Pamela Hunt of New Hampshire Audubon. Nest locations were digitized in GIS software using 2015 base aerial photography. However, positional accuracy is uncertain and best used at 1:24,000 scale or greater. These nest sites do not necessarily represent all eagle or osprey nest locations in New Hampshire seacoast area but are known active nest sites. Nest locations for areas in Maine are included as polygons in the BIRDS (Bird Polygon) data layer. (Citation: SUMMARY OF BIRD USE OF NEW HAMPSHIRE COASTAL AREAS (INCLUDING GREAT BAY))
