This data set contains sensitive biological resource data for horseshoe crab in Maine and New Hampshire. Vector points in this data set represent horseshoe crab spawning sites. Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for Maine and New Hampshire. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the INVERT (Invertebrate Polygons) data layer for additional invertebrate information.

Process Steps:

- 2016-01-01 00:00:00 - Invertebrate points data layer contains horseshoe crab spawning locations based on a 2006 digital point data set from the Maine Department of Marine Resources (MDMR). These areas are critical for successful reproduction of horseshoe crabs and since they lay eggs in the intertidal, they are particularly susceptible to oil spill events. These are known regionally important areas but do not include all areas where spawning activity may be taking place. The point data was originally compiled by MDMR from three primary sources: Born, 1976; Schaller, 2003; and Thayer, 2004. Point data were based on latitude and longitudes provided in the primary sources. (Citation: HSCLOCATIONS (MAINE HORSESHOE CRAB LOCATIONS))
