This data set contains sensitive biological resource data for terrestrial mammals in Maine and New Hampshire. Vector polygons in this data set represent known terrestrial mammal concentration areas. Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for Maine and New Hampshire. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2016-01-01 00:00:00 - The terrestrial mammals depicted in this data are limited to the New England Cottontail (*Sylvilagus transitionalis*, state/federally endangered), northern river otter (*Lutra Canadensis*), muskrat (*Ondatra zibethicus*), and beaver (*Castor canadensis*). Other mammals are potentially occurring in the study area, but are not mapped due to their relatively wide distribution, a lack of information regarding particular concentration areas, and/or the unlikelihood of impact during coastal and marine oil spills due to their use of more upland and inland habitats. The primary source used to depict habitat distribution and seasonality in Maine for this data layer was the ETSC (Endangered, Threatened, or Species of Concern) digital data from the Maine Department of Inland Fisheries and Wildlife (MDIFW). Additional information on the New England Cottontail was provided by the U.S. Fish and Wildlife Service (USFWS). Terrestrial mammal distribution data for New Hampshire included consultation and direct markup of 1:24,000 base maps by Steve Jones of the University of New Hampshire. All digital data obtained from NH and Maine for the Terrestrial Mammals Layer were edited as necessary to match NOAA ESI Shoreline layer included in this atlas.
