1.2. Summary description of the data:

This data set contains polygons that represent the following sensitive human-use management areas in Maryland: wildlife refuges, national parks, wildlife management areas and sanctuaries, state parks, conservation lands, state forests, and terrestrial communities. Location-specific type and source information is stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for Maryland. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the SOCECON (Socioeconomic Resource Points and Lines) data layer, part of the larger Maryland ESI database, for additional human-use information.

Process Steps:

- 2007-04-01 00:00:00 - Existing digital data sets from Maryland Department of Natural Resources (DNR), U.S. Fish & Wildlife Service (USFWS), and Assateague Island National Seashore (ASIS) were used to depict human-use resources for this data layer. The above digital and/or hardcopy sources were compiled by the project biologist to create the MGT data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: (1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; (2) hardcopy maps are digitized at their source scale; and (3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The compiled ESI, biology, and human-use data are plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews is conducted to review the maps. If necessary, edits to the MGT data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
