The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. - 2009-12-01 00:00:00 - 1996 National Wetlands Inventory (NWI) data were used in the classification of polygonal wetlands. The polygonal wetlands were spatially

modified based on the 2006 georeferenced oblique aerial photographs, 2007 Mississippi Department of Information technology Services (MDITS) vertical aerial photography, and 1995 Mississippi ESI atlas HYDRO data. Spatial revisions to the tidal flats from the 1995 atlas, where appropriate, were integrated using the oblique aerial photographs and MDITS vertical aerial photography.
