1.1. Name of the Data, data collection Project, or data-producing Program:

North Slope, Alaska ESI: BIRDS (Bird Polygons)

1.2. Summary description of the data:

This data set contains sensitive biological resource data for diving birds, gulls and terns, seabirds, shorebirds, and waterfowl for the North Slope of Alaska. Vector polygons in this data set represent nesting, brood rearing, migratory staging, and molting sites for birds. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for North Slope, Alaska. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the NESTS (Nest Points) data layer, part of the larger North Slope, Alaska ESI database, for additional bird information.

Process Steps:

- 2005-01-01 00:00:00 - Four main sources of data were used to depict bird distribution and seasonality for this data layer: (1) personal interviews with resource experts from U.S. Fish and Wildlife Service (USFWS), U.S. Geological Survey (USGS), Alaska Department of Fish and Game (ADF&G), Canadian Wildlife Service (CWS), University of Alaska-Fairbanks (UAF), and ABR, Inc.; (2) numerous published and unpublished reports, maps, and survey data provided by the agencies listed above; (3) peer-reviewed journal articles and books; and (4) digital data. The digital data included four USFWS vector polygon coverages depicting waterfowl nesting and molting distribution in 2002-2003 and two 2004 digital tables (provided by ABR, Inc. and USFWS) depicting bird nesting and/or brood rearing locations. Concentration and seasonality information was provided by resource experts or was extracted from published sources, reports, and survey data. The above digital and/or hardcopy sources were compiled by the project biologist to create the BIRDS data layer. Depending on the type of source data, three general approaches are used for compiling a biology data layer: (1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:250,000 topographic quadrangles and digitized; (2) hardcopy maps are digitized at their source scale; (3) digital data layers are evaluated and used 'as is' or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The compiled ESI, biology, and human-use data are plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews are conducted to review the maps. If necessary, edits to the BIRDS data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
