This data set contains vector lines and polygons representing the shoreline and coastal habitats of New Hampshire classified according to the Environmental Sensitivity Index (ESI) classification system. This data set comprises a portion of the ESI for New Hampshire. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2004-03-01 00:00:00 - The intertidal shoreline habitats of New Hampshire were mapped during overflights and ground surveys conducted by an experienced

coastal geologist in October 2003. The overflights of New Hampshire were conducted using a fixed-wing aircraft, flying at elevations of 400-600 feet and slow air speed.

During this work, the ESI rankings of observed intertidal shoreline habitats were denoted directly onto the shoreline depicted on 1:24,000-scale USGS topographic maps. Where appropriate, revisions to the existing shoreline were made; where necessary multiple habitats were described for each shoreline segment. In addition to the ESI shoreline habitats, wetland data for New Hampshire are also depicted on the maps. The Complex Systems Research Center, University of New Hampshire delineated wetlands for the study area. The coastal geologist classified the wetlands based on overflight and ground survey experience.
