1.2. Summary description of the data:

This data set contains sensitive biological resource data for marine, and estuarine invertebrate species in New Hampshire. Vector polygons in this data set represent invertebrate distribution. Species specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for New Hampshire. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2004-03-01 00:00:00 - Three main sources of data were used to depict invertebrate distribution for this data layer: 1) personal interviews with resource experts from the University of New Hampshire (UNH), the New Hampshire Estuaries Program (NHEP), New Hampshire Department of Environmental Services, and the Great Bay National Estuarine Research Reserve; 2) 2002 digital coverage depicting distribution of softshell clam and Eastern oyster provided by the University of New Hampshire and New Hampshire Fish and Game (NHFG); and 3) NOAA's Estuarine Living Marine Resource Program (ELMR) report titled, "Distribution and abundance of fishes and invertebrates in North Atlantic estuaries." Information gathered from resource experts was compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles. The compiled data was digitized off of the base maps into an ArcInfo system to create the INVERT data layer. The digital coverages were incorporated into this data layer. All ESI, biology, and human-use data was plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews was conducted to review the maps. Edits to the INVERT data layer were made based on recommendations made by the resource experts, and final hardcopy maps were created. Resource experts provided concentration and seasonality information.
