Sensitivity of Coastal Environments and Wildlife to Spilled Oil: New Hampshire: NESTS (Nest Points)

1.2. Summary description of the data:

This data set contains sensitive biological resource data for nesting birds in New Hampshire. Vector points in this data set represent locations of nesting osprey and roosting bald eagles. Species specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for New Hampshire. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the BIRDS data layer, part of the larger New Hampshire ESI database, for additional bird information.
