This data set contains sensitive biological resource data for northern river otters, beavers, and muskrats in New Hampshire. Vector polygons in this data set represent terrestrial mammal distribution. Species specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the Environmental Sensitivity Index (ESI) data for New Hampshire. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2004-03-01 00:00:00 - The main source of data used to depict terrestrial mammal distributions for this data layer was expert knowledge provided by U.S. Fish and Wildlife Service (USFWS), New Hampshire Fish and Game (NHFG) and the University of New Hampshire (UNH). Information gathered from these sources was compiled onto U.S. Geological Survey (USGS) 1:24,000 topographic quadrangles. The compiled data was digitized off of the base maps into an ArcInfo system to create the T_MAMMAL data layer. All ESI, biology, and human-use data was plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews was conducted to review the maps. Edits to the T_MAMMAL data layer were made based on the recommendations of the resource experts, and final hardcopy maps were created.
