Environmental Response Management Application (ERMA) ® is a web-based Geographic Information System (GIS) tool that assists both emergency responders and environmental resource managers in dealing with incidents that may adversely impact the environment. ERMA ® integrates and synthesizes various real-time and static datasets into a single interactive map.

Arctic ERMA is an online mapping tool that brings together the available geographic information needed for an effective emergency response in the Arctic, including the extent and concentration of sea ice, locations of ports and pipelines, and vulnerable environmental areas. ERMA integrates data—some occurring in real time such as weather and ice radar—into a single interactive map, providing a quick visualization of on-the-ground conditions, and improving communication and coordination among responders and environmental stakeholders.
