Sensitivity of Coastal Environments and Wildlife to Spilled Oil: South Florida: INVERT ( Invertebrate Polygons)

### 1.2. Summary description of the data:

This data set contains sensitive biological resource data for marine and estuarine invertebrate species in South Florida. Vector polygons in this data set represent invertebrate distribution and concentration areas. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the ESI data for South Florida. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2013-04-01 00:00:00 - Four main sources of data were used to depict invertebrate distribution and seasonality for this data layer: 1) personal interviews with resource experts from the Florida Fish and Wildlife Conservation Commission - Fish and Wildlife Research Institute (FWC-FWRI); 2) digital data sets provided by FWC-FWRI; 3) fishery-dependent catch data; and 4) published and unpublished reports. Queen conch aggregation sites were derived from areas delineated by FWC-FWRI survey data. Site information has been generalized to include areas that may be used due to annual variation. Contact FWC-FWRI for more specific information on the abundance and distribution of any invertebrate species. The above digital and/or hardcopy sources were compiled by the project biologist to create the INVERT data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The compiled ESI, biology, and human-use data are plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews are conducted to review the maps. If necessary, edits to the INVERT data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
